5. Other – General

5.1 General Manager Report – August

B. LeBlanc presented General Manager's Report:

 XYZ strategy, branding, communications branding exercise – XYZ agreed to split the project in two phases, 2013 and 2014 phase each for \$45,000.00, the first one is communications and branding and the second one would be the compost commercialization project. They are canvassing stakeholders and decision makers and getting their feedback on the Commission. We have always focused on what comes into the plant, but if we are looking at improving our imaging or branding, should we instead look at what comes out of the plant? Emphasize, outflow rather than inflow. Meeting with XYZ over the next few weeks, to incorporate what we have in budget and get XYZ's feedback in terms of how to position that, based on the feedback they have received from their interviews.

- Visit from Surfer Magazine The reporter that is writing an article for surfer magazine visited yesterday, to meet with us and tour the facility as well. Proposed that a response be provided to the media about surfing in the river. Draft letter was presented.
- We are looking at advanced treatment and we will have it completed by 2020.
- B. LeBlanc met with Fred Blaney, partnership New Brunswick for the province and David Winters, the P3 arm of the Province.
- B. LeBlanc says had a good meeting with Province today. The Board for P3 Canada meets twice a year, before the end of the year they will have decided on this Phase V who gets the money. B. Hicks says it's very important that it be done right.
- New compost building update On September 3rd, contractor expects to be on site to complete work, with all work expected to be completed in September and occupancy in October. The only outstanding issue being that the electrical inspector must buy in to the proposed electrical changes. J. Thériault suggests once it is all completed, should we do an open house? Commission agreed.
- Request for proposals to the IT people Next priority. Five potential
 companies have been identified that could provide the service and they
 would be provided the information about our system, servers, email, etc.
 Late October seen as timeframe for decision on who should support our
 IT.
- GMSC Mission proposed as: "To provide reliable, cost-efficient and environmentally responsible wastewater transmission and treatment" and agreed to.

- GMSC Vision proposed as: "To be an outstanding environmental steward supporting regional planning, economic development, and quality of life for the communities of Dieppe, Moncton and Riverview"
